OLD BUSINESS

6. Readiness for March Show

Awards have been purchased. Class prizes are boxes. High Point prizes are saddle pads.

A request has been made by a competitor to have a paddock door that is usable - Louisa will inspect stalls per Jackie.

It was decided that a new policy for next year will allow 1 free stall per 4 hours worked at time of show for volunteers with multiple horses

Entries — There are 50 class entries. Only the standard dressage arena size will be used for this show to facilitate ride scheduling.

Lunch — Rachel will arrange lunch, donated by Magnolia Sport Horse. Lunch will be Publix sub platters.

7. Mailchimp

Cynthia noted that the email on the show registration form sometimes does not match the membership email on Mail Chimp. Barb explained that the membership email in Mail Chimp

is an automatic upload from the online Membership application. However, the email entered on the show registration form is NOT uploaded to Mail Chimp.

NEW BUSINESS

1. Update to Online Show Entry System

A 4th class option has been added to the on-line show entry system to allow for Dressage Seat Equitation to be added outside the three test limit. No additional riders have entered.

3. Ride Time Policy Discussion
